9. Special Resolution - Changes to the constitution of Business East Tamaki, as required by the Incorporated Societies Act 2022, and intent to re-register – Brendan Kelly

Reason: The Association is now governed by the new Incorporated Societies Act 2022. It requires the Association to re-register under the Act by April 2026. The Executive Committee has decided to take the opportunity presented by the Annual General Meeting to hold a Special General Meeting immediately following the conclusion of the Annual General Meeting to adopt rules for the Association which are in compliance with the new Act and to approve the re-registration of the Association under the Act.

The existing rules of the Association only required minor changes. These are summarised in the comparison of the Rules with the Act and by reference to the accompanying revised Rules available on the Association's website www.businessET.org.nz/event/2024-agm. The opportunity has also been taken to tidy up some typographical and other minor matters. The changes are indicated in the marked-up copy but a clean copy will be filed with the Registrar of Incorporated Societies.

Pursuant to existing Rules 26, 27 and 36 notice is given of the intention to pass the following resolution as a Special Resolution:

Special Resolutions – It is resolved that (1) Business East Tamaki Incorporated adopt as its new Rules the Rules made available to Members in the notice of this Special Resolution and to re-register Business East Tamaki Incorporated under the Incorporated Societies Act 2022 and that (2) its Executive Committee be authorised to take such actions and sign such documents as may be necessary or desirable to give effect to that re-registration.
